- Only acoustic and percussion instruments are allowed: the use of electronic instruments is strictly prohibited.
- Any unforeseen situations not covered in the guidelines will be subject to the final decision of the judges.
- The organizing team reserves the right to disqualify any team in case of irregularities or discrepancies.
- Usage of any kind of Plastic or hazardous props is strictly prohibited.
- The use of fire, water, or smoke machines on or near the performance area is at the team's own risk.
- Winners will receive certificates.

About St Joseph's University.



St Joseph's University (SJU) is a Jesuit University at the heart of Bengaluru, the Silicon city of India. Established in 1882 by Paris Foreign Fathers, the management of the college was handed over to the Jesuit Order (Society of Jesus) in 1937. The college was first affiliated to the University of Madras and later to the Mysore and Bengaluru Universities. In 1986, St Joseph's College became the first affiliated college in Karnataka to offer postgraduate courses. In 1988, it became the first college in Karnataka to get a research centre and in 2005, it was one of five colleges in Karnataka that was awarded academic autonomy. In February 2021, St Joseph's University bill was presented in the Karnataka Legislative Assembly and was subsequently passed by the Legislative Assembly and Karnataka Legislative Council. The college received its University status on 2nd July 2022 and was inaugurated as India's first public-private university by the President of India, Smt. Droupadi Murmu on 27th September 2022.

School of Social Work

The Department of Social Work at St Joseph's University was established in the year 2005 and it was raised to a School in 2021. The School of Social Work is the only one in the University that offers three different programs within the same discipline. The School is committed to the pursuit of social work campaigns to improve the quality of life of the downtrodden. The School looks for individuals who inherently possess a commitment to bring about positive change in society and thus provides them with the right amount of training and orientation to fulfill their deeds in the most effective manner. The academic program is rigorous so as to enable students with an appropriate attitude and knowledge to effectively address social problems in the world. Our educational mission is to prepare social work practitioners skilled in critical self-reflection, in working with individuals, families, groups, and communities and to enhance the well-being of the people of our Nation and around the world. Our scholarly mission is to share and create collective knowledge and understanding through engaging in critical enquiry by supporting research and innovative curriculum development at the undergraduate and post graduate level. Our practice mission is to act on social justice issues through community change initiatives by challenging the oppressive societal structure, thus reaffirming the importance of respectful, meaningful and collaborative relationships as core elements of social work practice.

About the University of Houston - Downtown (UHD)



The University of Houston-Downtown (UHD), founded in the 1970s at One Main Street, has grown from offering its first four-year degree in Criminal Justice to becoming a leading metropolitan university. Recognized as Texas' third fastest-growing university by the 1990s, UHD expanded its programs to include graduate degrees, forged partnerships with Lone Star College, and developed transfer pathways for community college students. The university's campus grew significantly with the addition of facilities like the Shea Street Building for the College of Business, the College of Sciences & Technology Building, and the Wellness & Success Center. In 2017, the College of Business was renamed the Marilyn Davies College of Business after a \$10 million endowment. Today, UHD serves over 14,000 students annually, is a Hispanic-Serving and Minority-Serving Institution, and remains committed to fostering a diverse, dynamic, and workforce-aligned educational environment.

GUIDELINES FOR ABSTRACT SUBMISSION

- Abstract should not be more than 250 words with headings such as introduction, methodology, results, conclusion, and keywords (3-5 key words).
- The abstract should contain the title of the paper, name(s) of the author(s), designation and institutional affiliation of authors, and contact details (email ID and phone number) of the presenting author at the end of the abstract.
- Conference registration is mandatory for all the presenting authors.

GUIDELINES FOR FULL PAPER SUBMISSION

- Full Paper should NOT be more than 3000 words with headings such as introduction, methodology, results, discussion, and conclusion.
- Referencing style: APA 7th Edition
- Declaration by the author regarding conflict of interest and ethical clearance are must.
- Full paper must contain the title of the paper, name, designation, institutional affiliation of authors, and contact details (Email ID & contact address) of the presenting author.
- Times New Roman style, with font size 12 and 1.5 spacing in a single file in MS Word format.
