Eligibility

- Students enrolled in the BBA, BFIA, B.Com. (H, E), Bachelor of Management Studies (BMS), Integrated
 Program in Management (IPM), B.A. (Economics), Bachelor in Business Studies (BBS), or any other financerelated degree courses are eligible.
- Applicants must have secured at least 80% marks in Classes 10 and 12 (For PwD students, the minimum percentage required is 70% marks).
- The annual family income of the applicants should be less than INR 6 lakh.
- Open for Indian nationals only.
- The children of employees/contract employees of Hero FinCorp, Raman Kant Munjal Foundation, and Buddy4Study are not eligible to apply.

Benefits

- Scholarships ranging from INR 40,000 to INR 5,50,000 per year will be awarded to each scholar for three
 years to complete their education.
- The exact scholarship amount will depend on the accepted college fee.

- Aadhaar card of the applicant
- PAN card and Aadhaar card of the parents
- <u>Income proof</u> (ITR all 7 pages reflecting all accounts / Income Certificate / Salary slip of salaried parents)
- Bank account statements of the applicant's parents
- Current year admission proof

- College fee receipt/demand receipt issued by the college
- Affidavit (stating that all the documents provided by the applicants are true to their knowledge)
- Passport size photograph
- Note: The applicant will be required to upload all the self-attested docume
